## **Directions to the Event Site From I-81 (North or Southbound)**

**Take I-26 toward Johnson City. Take Exit 13 (Old Exit 42) and turn right onto Suncrest Drive (Hwy.75). McDonalds will be on the right. At the Dairy Queen turn left onto Old Gray Station Road. At the Sit n' Bull Restaurant turn left onto Gray Station Road. Turn right onto Chapel Road. Take the curve to the left past the Church and the Fairgrounds Entrance is at the top of the hill. GO PAST MAIN ENTRANCE to Maple Dr turn left and gate to FAST CAT will be on your left. THIS GATE WILL BE CLOSED AT THE START OF THE TEST, ENTRY AT FRONT GATE WILL REMAIN OPEN**

There are several fast food restaurants close to the trial site There is no shade at the FAST CAT site so plan accordingly.

### **General Information**

- ⌚ Dogs must be one year of age or older on the day of the test.
- ⌚ The running order of Fast CAT's will be at the discretion of the field committee, typically on a roll call basis. Priority for field committee dogs running will be given to free them up to work the tests.
- ⌚ The field committee reserves the right to bar known aggressive dogs from the event site.
- ⌚ There will be a \$5 fine assessed for any loose dog not taking part in the course in progress, or for anybody caught not picking up after their dog or leaving garbage on the field.
- ⌚ NO ONE will be allowed on the field without the express permission of the Field Chairman, except the appointed field committee.
- ⌚ Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
- ⌚ Control of dogs will be strictly enforced, dogs must be on leash at all times except when running.
- ⌚ Clean up and dispose of all trash.
- ⌚ Please pick up after your dogs and remove with trash or put in receptacle provided at site.

### **Practice**

Practice runs will be held Friday and Saturday only, if weather, equipment and daylight permit. Practice is \$5.00 per dog/per run. **Practice will NOT be offered on Sunday**
